Course Curriculum:

[1] This certification Course will involve training for 4-6 months, starting from the date of joining [virtual and/or classroom sessions].Total weekly training is 12-15 hours. Total course duration involves 200-250 hours. Course/ Internship model will be a mix of classroom and online training sessions in service lines including accounting, compliance, auditing, risk management, wealth advisory, consulting and sustainability.

[2] 20% of the sessions are allocated for field work, primary research, workshops and interactive sessions by domain experts. The course will include real-life case studies for participants to gain understanding of key financial concepts, its practical applications and from sectoral and industry-specific perspective.

[3] The course can be pursued in tandem with academic or professional courses. Mentoring will focus on developing communication and AI skills, including ethics, teamwork and leadership qualities.

[4] To be considered for internships and placements, with Virtuedge Group Entities. Participants are expected to complete a thesis on a mutually agreed industry-specific topic as a test or live research paper.

Stipend and Other Benefits:
